Practices:

- User stories Huddles.
- Testers in architectural designs decisions sessions.
- Discuss defects not hand over Tickets (Jira)
- Collaborate on high-level acceptance criteria

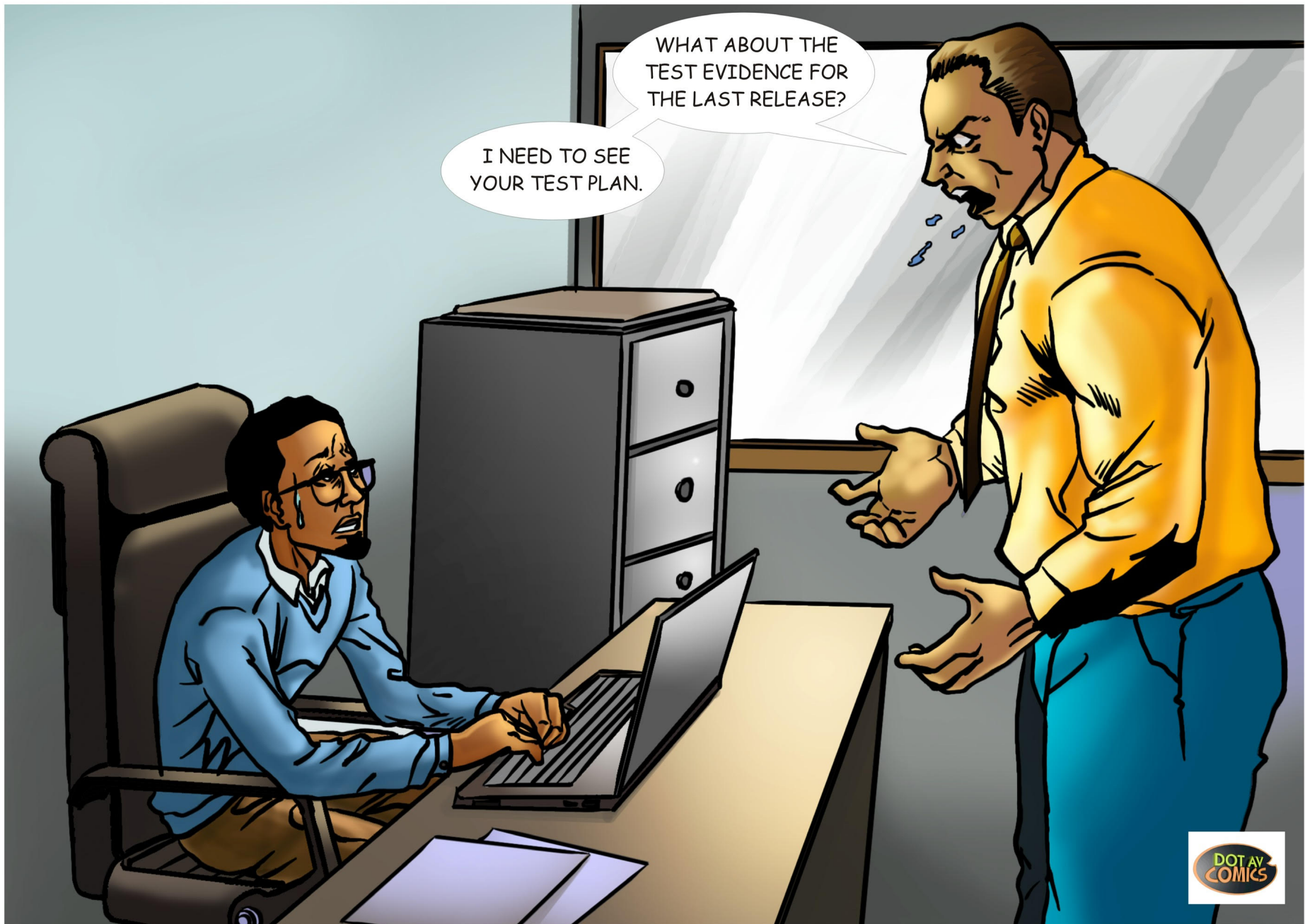
Benefits

- Reduce Test Duplication across layers within the Test Pyramid
- Testing is pushed to the left as far as possible.
- Higher chance of representing business expectations.
- Increase confidence of the business in the product being built.
- A culture of the co-ownership of code and tests is a by-product of these sorts of working practices.

Practices

- Publish a Test Approach document
- Tests as living documentation.
- Automate Test Reports
- Performance tests as part of the pipeline.

Benefits

- Time made available for higher value activities
e.g. Exploratory Tests
- Test and Quality is visible to all and Trust is established

Practices

- Tests should reflect expected customer behaviour.
- Chosen Test framework should be expressive (DSL Test Framework).
- Test report is fluent and readable
- Make Tests reports should be visible

Benefits

- User Acceptance Testing phase can be removed. (UAT)
- Business users' time is being used effectively, upfront and continuously.

Practices

- Everyone regards tests as an integral part of the product.
- Definition of DONE should include all tests.
- Everyone needs to seek and exploit opportunities to tests at the level with minimal cost.
- Test effort should not be estimated separately from the development efforts.
- As much as possible tests should be automated

Benefits

- As tests are integrated into the deliverable, there isn't any extra effort to test changes apart from the actual effort to make the change.

Lets go home ...

- Quality Checks (Tests) are embedded in User Stories, Unit Tests and Acceptance Tests.
- Create opportunities for conversations that potential leads to removing the UAT Phase.
- A story not tested is not “DONE”.
- Write fluent tests and make test report visible.
